Saturday, October 11, is the day for everyone in Elks 335 to celebrate the 90th birthday of our Lodge. The theme is stated above, and we plan to have a day totally reflecting the period of our origination.

The afternoon (12:30 to 4:30 p.m.) will be devoted to the enjoyment of our youngsters. Perhaps the biggest attraction will be the pony rides (yes, with live ponies). There will be races, such as three-legged, sack, wheelbarrow, and others. Plus food of the era . . . hot dogs, drinks, and more.

Dinner will be served from 5:30 until 8 p.m. There are two choices: steamship round of beef or baked ham with pineapple sauce. In addition, there will be ovenbrowned potatoes, rice pilaf, peas, relish tray and salad. Of course, hot rolls/butter and beverage will be available. And you can top it off with dessert.

Dancing will be from 8 p.m. until midnight, with music provided by the popular Dave Chatfield group. As most of us know, they will play all types of music, including the modern (meaning 1980's) tunes. Additional entertainment will be provided by a Barbershop Quartet, at this time unidentified. But they will render more enjoyable music during the breaks.

Let's not forget, there will be judging to determine the best Gay '90's costumes. An award of \$25 will go to the couple judged the best. And the best dressed individual will also receive a \$25 award. A runner-up in each category will receive a bottle of champagne.

To defray the costs of this gala event, there will be a \$15 per person surcharge. Admission to the Lodge will be by ticket only. Advance ticket purchases are encouraged.



INDIGNANT COMMUNITY

Chastity of Fresno Girls Assailed Traveling Preacher's Remarks From The Pulpit

(A Committee Compels Him to Sign an Apology, Then Orders Him to Leave Town

FRESNO, MARCH 27 — The people of Fresno were aroused to a state of warm indignation this morning by the publication in the Morning Republican of an article denouncing Rev. I.T. Johnson, the traveling Evangelist, who has been holding meetings in the Methodist church for some weeks for having repeated from a pulpit a statement which he claimed had been made to him that two-thirds of the girls of this city were ruined before they reached the age of 14 years.

The paper also contained an interview with the preacher in which he having repeated the statement, but declined to give his source of information.

A citizens meeting was called this evening at which Johnson was made to appear. He at first made a general denial of the interview, but finally admitted he had repeated the slander attributed to him. Upon demand of the committee he signed the following categorical admission and apology: "Do you believe that the statements made by you regarding the chastity of the girls of this city which you claim was told you by a friend was untrue, and that you made a mistake when you repeated this statement?" "I do and that I will apologize to the community for having made the same." (Signed) "I.T. Johnson."

The foolish preacher was then ordered to leave town, which he did.

OUR COMMITTEES ACT

Democrats Show Their Anxiety to Secure Statehood

On Friday, both the territorial and county committees of the Democratic Party acted promptly and have called the Executive Committees together to meet on Tuesday next, at which time an urgent appeal will be made to Congress to hasten the admission of Arizona. B.A. Fickas issued the following dated at Phoenix, March 27:

"A meeting of the Executive Committee f the Democratic Territorial Central Committee is hereby called to meet at Phoenix on Tuesday, March 31, for the purpose of taking action in regard to the bills for the admission of Arizona now floundering before the House Committee on territories, and to express to said committees the sentiments of this committee regarding same.

"Every Democrat feels a keen interest in this question, and the party as a unit is in favor of admission at the earliest possible date. Should it be impossible for you to attend in person, which I hope will not be the case, will you please mail or wire your proxy to some of the committee who will be in attendance so that there will be no delay in forwarding the result of the meeting to Washington not later than the first of next month.
